## QUEENSLAND NOMINATION CONDITIONS

### BUSINESS INNOVATION AND INVESTMENT (PROVISIONAL) VISA (SUBCLASS 188)

You must meet the Department of Home Affairs' Immigration Eligibility Criteria and Migration Queensland's state nomination conditions to be considered for Queensland nomination for your 888 visa (Permanent Residency). Please ensure you take into account of nomination application processing time frame when planning to lodge your 888 visa application.

#### EOI for 188 visa submitted between 14 July 2016 and 1 July 2021

##### **Business Innovation stream – subclass 188**

You must commit to your proposed business investment in Queensland and your proposed funds transfer of at least A\$800,000 to Queensland within two years of being granted your 188 visa. Please advise MQ when your business is established and operational.

##### **Investor stream – subclass 188**

You must maintain your Designated Investment of A\$1.5 million in Queensland Treasury Corporation (QTC) bonds for at least:

- 4 years if your provisional visa application was lodged on or after 1 July 2015; or
- 3 years and 11 months if your provisional visa application was lodged before 1 July 2015.

You must commit to your proposed funds transfer of at least A\$2.25 million to Queensland (including A\$1.5 million being invested in QTC bonds).

You must also commit to residing in Queensland for at least two years out of past four years immediately before applying for your 888 visa nomination.

##### **Significant Investor stream – subclass 188**

You must maintain your A\$5 million Complying Investment for the entire period of your provisional visa. You must meet your residence requirement in Queensland, Australia.

##### **Entrepreneur Stream – subclass 188**

You must maintain your entrepreneurial activities in Queensland.

**You must meet the residence requirements set against your visa stream.**

#### EOI for 188 visa submitted on and after 1 July 2021

##### **Business Innovation stream - subclass 188**

You must commit to your proposed business investment in Queensland and your proposed funds transfer of at least A\$1.25 million to Queensland after being granted your 188 visa. Please advise MQ when your business is established and operational.

##### **Investor stream – subclass 188**

You must maintain your A\$2.5 million Complying Investment for the entire period of your provisional visa. You must also commit to residing in Queensland for at least two years out of past three years immediately before applying for your 888 visa nomination.

##### **Significant Investor stream – subclass 188**

You must maintain your A\$5 million Complying Investment for the entire period of your provisional visa. You must meet your residence requirement in Queensland, Australia.

##### **Entrepreneur Stream – subclass 188**

You must maintain your complying entrepreneurial activities in Queensland.

**You must meet the residence requirements set against your visa stream.**

### BUSINESS TALENT (PERMANENT) VISA (SUBCLASS 132) – SIGNIFICANT BUSINESS HISTORY

You must commit to your proposed business investment in Queensland and meet your obligations to participate in 132 visa survey in 2–3 years after your arrival.
